STEP 1 — GETTING STARTED

R&L Design Co. will develop four furniture and artwork packages that complement the fixed finish schemes. These curated packages will be available for review twelve months prior to building completion. These packages will be showcased within typical layouts for a 2-bedroom residence, 3-bedroom residence, 4-bedroom residence and a Cloudstone series residence. Preliminary pricing will be provided for these plan types.

To purchase a package, please email R&L Design Co. at hello@rldco.com with your residence number and interior finish selections. Please inform us of any upgrades you've chosen and indicate if you are joining the Snowmass Mountain Lodging (SML) rental program, as we will exclude the linen and housewares items that will be provided by SML. We will then schedule a discovery call to review your residence layout and address any questions you may have regarding the packages.

If you decide to proceed, a \$2,000 non-refundable deposit is required. This amount will be applied toward your final balance. Once the deposit is received, R&L Design Co. will adjust the package for your residence floor plan. Please note that the deposit confirms your intent to proceed and is non-refundable if you later cancel.

STEP 2 — FINAL DESIGN REVIEW

R&L Design Co. will provide a reservation package containing a scaled and coded furniture plan, with an image and description of each item included. In addition, you will receive a Purchase Agreement with the total cost including delivery and installation, specific to your residence plan type.

To ensure the best pricing and to have the furnishings ready for installation shortly after closing on your residence, please complete this step within the announced deadline.

STEP 3 — PURCHASE AGREEMENT

No later than the announced date, you must sign the Purchase Agreement provided in Step 2 and provide a 75% deposit.

R&L Design Co. will then begin the purchasing process, managing the ordering, receiving, inspection, and storage of all items.


